## TASK FORCE ON EQUAL ACCESS TO JUSTICE

The TADC continues to actively participate as a member of the Texas Access to Justice Commission Supreme Court Task Force to Expand Legal Services Delivery. The Task Force met in December of 2009 and the TADC was represented by Pamela Madere with Clark, Thomas & Winter, P.C. in Austin. One of the many issues the Task Force is evaluating is the manner in which pro bono hours are reported because strong pro bono participation improves the State Bar's ability to secure funding from the legislature. Currently, the primary method of tracking pro bono hours is by self reporting the hours on the State Bar website. The Task Force is interested in whether groups such as the TADC are able to track pro bono hours by its members. TADC has agreed to help the Task Force with this effort. The TADC will begin distributing a "Pro-Bono Hours Self Reporting" worksheet at all Association functions to assist the Task Force in their mission. # **LEGISLATIVE/RULES & POLITICS**

The Texas Rules of Disciplinary Procedure have recently undergone a massive review and a proposal with suggested changes has been sent to the Supreme Court for consideration. Statewide bar groups and legal associations were urged to comment on the proposed changes. TADC President Greg Curry appointed Luke Ashley with Thompson & Knight, L.L.P. in Dallas to formulate the TADC response. On December 31, 2009, TADC's comments were hand-delivered to the Supreme Court Rules Attorney Kennon Peterson. To see a copy of the proposed changes to the disciplinary rules, <u>CLICK HERE</u>. We reported in early December that Interim Charges had been released by the Speaker's office for House Committees. The TADC Legislative Committee, under Vice Presidents Mike Hendryx with Strong, Pipkin, Bissell & Ledyard, L.L.P. and Michele Smith with Mehaffy Weber, P.C. is working to provide both written and oral testimony around the state before any committee and on any charge relevant to the civil justice system.

As it currently stands, the committee with the most charges that would affect the civil justice system are in front of the House Committee on the Judiciary and Civil Jurisprudence, chaired by Rep. Todd Hunter (R-Corpus Christi). This Committee will begin a series of monthly meetings next week on a variety of issues of interest. The initial hearing on January 27 is devoted to arbitration, and TADC Vice President K.B. Battaglini, with Greenberg Traurig, L.L.P. in Houston has been invited to testify on behalf of the Association, along with representatives of the plaintiff's bar, arbitration industry, consumer groups, and business community. Future hearings will include paid and incurred in March, mesothelioma in April, and judicial campaign finance issues after that. The committee will also meet jointly with the House Business and Industry Committee on workers' compensation issues, but those meetings have yet to be scheduled.

The TADC Legislative Committee is busy reviewing all the charges of the committee and preparing analyses for use by the legislature. The latest analysis prepared by TADC discusses Committee Charge #6, a review of the Texas campaign finance law in judicial races in light of the recent United States Supreme Court decision *Caperton v. Massey*. Joint Interim Charge with House Committee on Elections. TADC East Texas Vice President Don Kent, with Kent, Good,

Anderson & Bush, P.C. in Tyler prepared the analysis on behalf of the TADC. To read TADC's response, <u>CLICK HERE.</u>

The big legislative issues for 2011 will be the budget and redistricting. Several major agencies are also up for sunset review, including the Texas Department of Insurance, Texas Department of Transportation, and Public Utility Commission. The workers' compensation system is also subject to review and will get plenty of attention in the next session.

Politically, recent polling data suggests that the Republican primary for governor is headed for a runoff between Gov. Rick Perry and Senator Kay Bailey Hutchison. Perry has consistently run about 10-12 points ahead of Hutchison in most polls, and the most recent Rasmussen survey confirms that. A third candidate, Debra Medina, has surged in recent weeks and now demonstrates double digit support. While she is not likely to draw more than 12-15% of the vote, her presence in the race could help down-ballot "Tea Party" Republicans in several contested House primaries (there are 17 in all). This could well have consequences for some Republican incumbents in March. On the Senate side, the sudden withdrawal of Sen. Kip Averitt (R-Waco) from his re-election campaign leaves a Republican challenger, insurance broker Darren Yancy, as the only active candidate in the race. Averitt will still appear on the ballot, however, creating the possibility that he could still win the primary and then withdraw from the race again. If that happens, the county chairs in the senatorial district will choose someone else to fill Averitt's ballot position.

With respect to other statewide races, former Houston Mayor Bill White faces a well-funded businessman, Farouk Shami, in the Democratic primary. White is expected to win the primary and will be a formidable candidate in the fall. Down the ballot looks very tough for Democrats, particularly in light of the general nationwide political trends evidenced in Massachusetts and elsewhere. All in all, most observers believe the Republicans will hold the statewide offices and increase their margin in the Texas House of Representatives by a few seats (it's currently 77-73). This should position Speaker Joe Straus very well for re-election as speaker when the House convenes next year.

### PAST PRESIDENTS REFLECTION

It has become customary for a TADC Past President to speak to the board on each day of the meeting to reflect on what TADC has meant to them through the years and how the Association has affected their practice and its impact on the civil justice system. Dewey Gonsoulin with Mehaffy Webber, P.C. in Beaumont and TADC President in 1978-79 addressed the board's Friday afternoon session. Mr. Gonsoulin described the legal climate in the mid-seventies and how the TADC made significant strides in involving itself in the political process. He advised that the formation of a PAC and legislative activism was necessary as the Trial Lawyers Association had been doing it effectively for years and the defense bar needed to respond. Mr. Gonsoulin praised the Association for the monumental contributions it has made towards the improvement of the civil justice system through the years.

Fred Raschke with Mills Shirley, L.L.P. in Galveston and TADC President in 2007-08 addressed Saturday's session.
