May 22, 2015

PLEASE NOTE: Calendar deadlines continue to trigger under the rules in both the House and the Senate. Today, May 22, 2015 is the LAST DAY the House may consider a local House Bill on 2nd or 3rd reading and tomorrow, May 23, 2015 is the last day a House Committee may report a Senate Bill.

On a related note, HB 1692 by Representative Sheets, relating to Forum Non Conveniens, is on the Senate Intent Calendar for today and is expected to come up for debate.
